Your 2022 impact on the kidney community

AKF created the **Unknown Causes of Kidney Disease Coalition**, made up of 15 organizations and individuals, to educate and inform patients, medical professionals and policymakers about the importance of patients receiving an accurate diagnosis for the root cause of their kidney disease.

Nearly **75,000** dialysis and transplant patients received help from AKF financial assistance programs, so they didn't have to choose between paying rent or medical bills and getting treatment.

20,000 AKF Ambassadors used their voices to influence public policy to improve the lives of people with kidney disease.

1,300 Kidney Health Coaches completed the AKF training course, bringing our total number of kidney disease educators nationwide to more than 6,400.

More than **30,000 people** participated in Kidney Action Week to access information, tools, and resources to prevent, detect and manage kidney disease.

This includes 1,767 low-income dialysis patients who received financial support for kidney transplants and continuity of care after surgery.


Understanding Causes of Kidney Disease: This year, through the **Unknown Causes of Kidney Disease (UCKD) Project**, we expanded our efforts to improve understanding of undiagnosed or misdiagnosed causes of kidney disease. AKF convened a diverse group of kidney care experts, organizations, and individuals to help people with rare kidney diseases get the answers and support they need. We also created a free continuing education course for primary care physicians on the importance of timely referrals to a nephrologist. And we published the findings of a survey documenting the barriers and opportunities to improving kidney disease diagnoses.

None of this important work would be possible without your support. We appreciate the trust you have placed in the American Kidney Fund, and we work hard every day to sustain that trust. We invest 97 cents of every dollar donated in our programs and services and have earned the highest ratings from charity evaluators for 20 consecutive years.

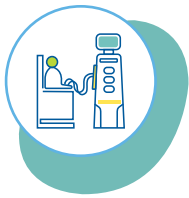

Addressing Health Disparities in Kidney Disease: Taking Action in Black and Latino Communities

In the U.S., the prevalence of kidney failure—the final stage of chronic kidney disease—among Black people is more than four times that of white people, while the prevalence of kidney failure in Hispanic or Latino people is more than twice that of white people. Studies have shown that racism and implicit bias within the health care system result in inequitable care for Black and Latino patients.

The American Kidney Fund is shining a light on these health disparities and is centering health equity within each of our Strategic Plan goals. We believe ALL patients should have equitable access to screening, resources and the care they need to live their best life possible. Our Health Equity Initiative seeks to:

- Prevent and slow the progression of kidney disease.
- Increase diversity in clinical trials to ensure the therapies being studied are tested in a representative population.
- Increase utilization of home dialysis as an accessible treatment option, resulting in better outcomes for patients.
- Remove barriers and increase access to kidney transplants among people of color.

In 2021, we launched the AKF Health Equity Coalition to spark the development of evidence-based programs and resources for underserved communities. This year, the coalition grew in size and impact and tackled disparities in care with fierce determination. We advocated for increased access to home dialysis in communities of color. Black and Hispanic people are 25% less likely to use home dialysis than White people. Also, this year, AKF worked with research partners to ensure people of color are represented in clinical trials.

Genetic Variation Leads to Kidney Disease: What Families Should Know

Emerging research confirms a strong connection between kidney disease and a genetic variation in the APOL1 gene. While everyone has two copies

of this gene, some people have a mutation (or variation) in one or both of the APOL1 genes. People who inherit mutations in both of their APOL1 genes are 10 times more likely to develop kidney disease. Found in people of African ancestry who may identify as Black, Caribbean or Latino, the mutation causes kidney disease to progress more quickly to kidney failure.

Detecting the APOL1 genetic variant among high-risk communities of color will greatly decrease risk of kidney failure and save lives. The American Kidney Fund is working to ensure health professionals and the kidney community know about the significance of the APOL1 gene and the urgency of expanding genetic testing in high-risk groups.

Thanks to support from Vertex Pharmaceuticals, AKF is bringing life-saving information and resources to the most at-risk patients.



Health Equity at the Forefront of Tackling Kidney Disease

All people deserve good health, no matter where they live, what language they speak or the color of their skin. But studies have shown that due to structural racism and implicit bias, Black and Hispanic people with kidney disease receive less optimal care, are more likely to advance to kidney failure and are less likely to receive a kidney transplant. We also know there is a strong association between financial instability and kidney health.

I'm proud to be working with the American Kidney Fund to address health disparities in kidney disease treatment. As a CSN fellow, I had the opportunity to join AKF's Health Equity Coalition when it was first formed. My involvement with the coalition shapes how I practice medicine every day.

I have especially enjoyed working alongside patients with kidney disease, other medical professionals, and non-profit organizations to identify and remove barriers to equitable kidney care. When you invest in groups like the American Kidney Fund, you enable early career nephrologists like me to make a difference beyond the walls of our medical office.

Helping People with Kidney Disease Thrive

There is nothing more central to our mission than our direct support to patients with kidney disease. It's been a core focus since the organization's earliest days. In 1971, a small group of neighbors came together to help a friend struggling with kidney disease and the American Kidney Fund was born.

Still today, our work is grounded in love and care, though our reach is far larger than a single neighborhood. Across our country, including right in your own community, people rely on our services. Thank you for helping AKF transform the lives of people with kidney disease in 2022 through the following programs.

Financial Assistance

The American Kidney Fund knows the kidney community well because we have been supporting families facing the disease for more than 50 years. In 2022, we provided more than 62,000 dialysis and transplant patients with access to health insurance through the Health Insurance Premium Program (HIPP). This grant program ensures that low-income dialysis patients can maintain their insurance coverage and receive the medical care they need.

We also provide essential assistance for kidney transplants—supporting 1,767 kidney transplants for lower-income dialysis patients in 2022 and ensuring they have continuity of care for a full year after. In fact, roughly 7% of all kidney transplants in the U.S. are supported by AKF.

With support from our generous donors, AKF's Safety Net Grant Program provided more than 10,000 grants to help people with health care expenses not covered by insurance, an increase of more than 30% from the previous year. Typical expenses included the cost of transportation to and from dialysis, over-the-counter medication, co-payments and lifesaving medical equipment.

These grants were made possible in part by the Robert I. Schattner Foundation, Wasily Family Foundation, Slomo & Cindy Silvan Foundation, Healthcare Initiative Foundation, Potomac Health Foundation, The Max and Victoria Dreyfus Foundation, Inc., and many others.

Disaster Relief Program

When a community is hit by a disaster such as a tornado or hurricane, people living with kidney disease are especially vulnerable. In 2022, the American Kidney Fund once again stepped up to help during devastating disasters. We distributed nearly \$120,000 in relief grants to 500 people with kidney failure who were affected by Hurricane Fiona in Puerto Rico, Hurricane Ian in Florida, wildfires in New Mexico and flooding in Kentucky.

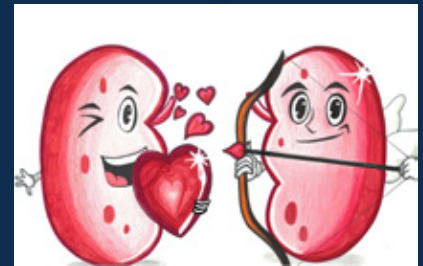
Also in 2022, the American Kidney Fund partnered with AdheRx to develop an emergency rapid response tool for the next disaster. With a new real-time tool, we will be able to contact kidney patients in disaster areas by text message to quickly identify their needs. Patients will receive real-time response offering resources and referrals to services in their area.

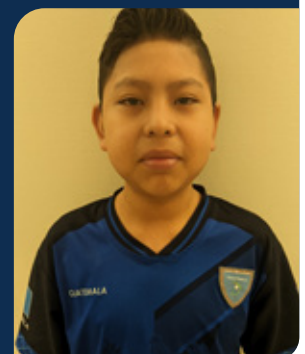


2022 Calendar Kid Winner

He was humble about his accomplishment and used the opportunity to encourage other children with kidney disease to remain hopeful. "Don't be scared of surgeries," said Yobani. "Everything will be okay."

Dozens of children and teens with kidney disease from across the United States submit their artwork for this annual contest, providing a creative outlet and national recognition for children living with kidney disease for 27 years.



AKF's National Camp Program: Inspiring Kids with Kidney Disease

More than 65,000 children in the United States are diagnosed with kidney disease each year. In 2022 we launched the American Kidney Fund National Virtual Camp, providing children a break from treatments and hospitals and allowing them to enjoy being a kid. First launched in partnership with Johns Hopkins Children's Center in 2020, this virtual camp expanded to a total of seven hospitals in 2022:

- Johns Hopkins Children's Center
- Cincinnati Children's
- Lucile Packard Children's Hospital Stanford
- Phoenix Children's
- Riley Hospital for Children at Indiana University Health
- Texas Children's Hospital
- UPMC Children's Hospital of Pittsburgh

More than 250 children and teens participated in 2022. Each child received a backpack with earbuds, a wireless charging station, coloring journal, water bottle and other items. Each month, these kids have the chance to set aside their doctors' appointments and all the challenges of living with kidney disease by joining our virtual camp sessions featuring activities such as bingo, arts and crafts and making gingerbread houses.

We're excited to announce that Camp All Stars at Johns Hopkins will return as a two-day in-person camp in 2023.

Profile: Ellie Hanley, 2022 American Kidney Fund Hero of Hope

Coming from a family of athletes, I always knew I wanted to run a marathon. It's something I dreamed about since I was very little. So, when I was diagnosed with kidney disease at the age of 11, I wasn't sure that would ever happen.

Today, I take 15 pills a day and have periodic infusions, but with the support of my medical team and my family, I live a relatively normal life.

In September 2021, I joined my mother and 25,000 other runners in the San Francisco Marathon. I wanted to support others with kidney disease, so I set a goal to raise \$26,000 for the American Kidney Fund. I'm thrilled to report that I finished the race, and also exceeded my goal—raising \$27,000 to support AKF's work.

I'm now a student at the University of Virginia and feel hopeful about my future. Thank you for supporting the American Kidney Fund and giving young people like me a chance to thrive.





Lifesaving Information for the Kidney Community

When it comes to life-threatening diseases, information is power. **And when people need information about kidney disease, they turn to the American Kidney Fund.**

Each year, millions access our website, trainings, and other resources. In 2022, we unveiled a completely redesigned website, **KidneyFund.org**. It's one of the most comprehensive online sources for information dedicated to kidney disease, kidney transplants and organ donation, and we focused on creating a website that would be user-friendly and rich with information. New this year, we've added more Spanish-language resources, and opportunities to get more involved as a Kidney Health Coach, an advocate or by hosting a personal fundraiser.

Home Dialysis: A Lifechanging Breakthrough

While home dialysis is growing in popularity, it is still widely underutilized, with just over 12 percent of all patients using home dialysis. For Black and Latino patients, that percentage is even lower. With your support, the American Kidney Fund is working to make home dialysis better understood and more accessible to all. In partnership with the nonprofit Home Dialyzors United, AKF hosted a virtual summit, *Dialysis at Home*, with nearly 1,500 registrants. It was a great opportunity for people with kidney disease and their families to evaluate treatment options.

The inaugural Dialysis at Home Summit was made possible with support from Satellite Healthcare and Outset Medical.

Third Annual Kidney Action Week

This year marked our third annual Kidney Action Week. It was a huge success, drawing more than 30,000 participants. The free nationwide virtual event offered a full week of live programming, and resources to help people prevent, detect and manage kidney disease.

Participants had the chance to get their questions answered during live broadcasts with top nephrologists, renal dietitians, caregivers, and other kidney experts. Plus, people were able to connect with other people living with kidney disease, share their common experiences and feel the power of our kidney community.

A highlight of the week was the Congressional briefing, *The Crisis in Kidney Disease*. A panel of national experts briefed Congressional staff and others about the alarming rates of kidney disease and kidney failure, which disproportionately affect people of color.

NFL Player Spotlights Kidney Disease: Pittsburgh Steelers Pressley Harvin III Supports AKF

When Pittsburgh Steelers punter Pressley Harvin III stepped onto the field on December 4, 2022, he was sporting a new pair of cleats that meant a lot. The gold and black cleats were designed to honor Pressley's father, Pressley Harvin Jr., who passed away on Christmas Day 2021. Pressley said, "I definitely felt [my dad] with me."

Harvin's father was diagnosed with kidney failure when the younger Pressley was just 16 years old. His father received dialysis treatments three times a week for many years before getting a kidney transplant. To honor his father's lifelong battle with kidney disease, the NFL player chose the American Kidney Fund for the My Cause My Cleats campaign.

Through the campaign, NFL players help raise awareness of a cause by wearing custom cleats during a game. Pressley said, "I just wanted to give people a little sense of awareness to the cause in general, because it's one of those sicknesses that if it's not in your family... some people don't really know the severity of it."

Thank you, Pressley, for honoring your father and raising funds to help others living with kidney disease. We are profoundly grateful.



Improving Our Understanding of Unknown Causes of Kidney Disease

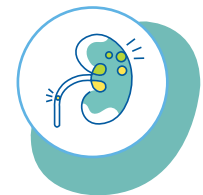
Optimal treatment of kidney disease is determined by its root cause. But, according to the U.S. Renal Data System, approximately 5% of kidney failure cases are attributed to unknown causes. People whose kidney disease cause is undiagnosed or misdiagnosed face more difficult treatment options and less optimal outcomes.

AKF's Unknown Causes of Kidney Disease (UCKD) Project drives innovation in research, diagnosis and treatment of the underlying causes of kidney disease. Under AKF's leadership, the Unknown Causes of Kidney Disease Coalition was formed in 2022, with 15 organizations and individuals working to increase understanding and advance public policy on rare kidney diseases.

AKF's Roadmap for Diagnosing Unknown Causes of Kidney Disease

The UCKD Project follows a roadmap, developed in 2021, for improving the diagnosis of the causes of kidney disease and kidney failure. The four pillars include:

1. **Advocate** for widespread and equitable insurance coverage of tests to help understand and diagnose kidney disease, including current and future tests related to genetics.

2. **Increase** providers' interest and awareness about the range of possible root causes of kidney disease through education and incentive structures.
3. **Educate** patients about kidney disease and testing in an effective, culturally competent way and empower them to advocate for an accurate diagnosis.
4. **Encourage** the development of national standards related to when and how genetic testing can be useful and applied.

In 2022, we advanced progress on these pillars with the following projects:

Survey of Healthcare Professionals

In 2022, AKF surveyed health care providers to understand opportunities and barriers in diagnosing chronic kidney disease. In the survey, health care providers estimated that 15% of their patients have kidney disease for which they do not know the cause. The survey also found that most health care providers do not utilize genetic testing despite its ability to

help provide a differential and definitive CKD diagnosis and cause.

AKF presented the provider survey at the American Society of Nephrology (ASN) meeting to increase awareness about the importance of genetic testing for chronic kidney disease. Through these types of public presentations, we are sparking dialogue about how to improve health outcomes and decrease disparities in care.

Continuing Education for Medical Professionals

When primary care physicians are better informed about renal disease and the testing options available, they are more likely to make a timely referral to a nephrologist. AKF developed a free, enduring CME course for primary care physicians on the topic of proper, early referral to a nephrologist, especially when the cause of CKD is unknown or suspected to be genetic in nature.

Federal Advocacy

Research shows that genetic testing can be a crucial tool for diagnosis and treatment of kidney disease. But many patients are not able to access the genetic tests that could provide needed answers. The American Kidney Fund is advocating for widespread and equitable coverage of genetic testing and counseling—and the addition of a recommendation for kidney screenings.

Driving Research and Treatment Forward

For many years, there was little innovation in kidney disease research and treatments. Thanks to strong advocacy from AKF, the tide is turning. Throughout 2022, we maintained a determined focus on research—for better treatments and, ultimately, cures. Below are some of the highlights of our research progress.

Increasing Diversity in Clinical Trials

To develop treatments that are safe for all people, clinical trials must include people from diverse backgrounds. But studies show that Black and Hispanic people, despite being more likely to face kidney failure, are underrepresented in clinical trials. For example, Black Americans make up about 12% of the U.S. population but only account for about 1% of participants in clinical trials.

This has to change, and AKF is leading that change with awareness and education campaigns about the importance of participating in clinical trials in communities of color and other underrepresented communities. We developed an interactive quiz and downloadable guide to help patients make decisions about participating in a clinical trial. And we're partnering with pharmaceutical companies and other researchers to help them connect with the diverse kidney community for their trials.

Sharing Research Breakthroughs

There is power in community and AKF collaborates with the medical community to share important research findings that will accelerate treatment breakthroughs for patients. Here are a few of the research

abstracts, clinical case reports and informational posters we presented in 2022:

- At the ASN Kidney Week 2022 Annual Meeting in Orlando, we presented our poster, “Barriers to genetic testing for determining cause of kidney disease among healthcare providers.”
- At the National Kidney Foundation’s 2022 Spring Clinical Meetings, we presented two posters on AKF programs: Kidney Health Coach™ (KHC) and Kidney Kitchen Pro™.

Investing in Researchers

Many of the most prominent researchers in nephrology have launched their careers through the American Kidney Fund’s Clinical Scientist in Nephrology Program. To address the urgent need for more highly trained investigators in the kidney field, the program invested \$320,000 in research grants in 2022.

Meet Our Fellows

This year’s AKF Clinical Scientist in Nephrology fellowships were awarded to two researchers dedicated to improving health outcomes for people affected by kidney disease.



Dr. Jillian Caldwell, DO is a nephrology fellow at Stanford University School of Medicine. Dr. Caldwell’s research examines how immunologic matching in kidney transplants impacts

equitable access to transplantation. While immunologically matched kidney transplants demonstrate better outcomes in terms of patient and kidney survival, racial and ethnic minorities are less likely to receive fully matched kidneys. Dr. Caldwell is examining the reasons for this disparity and evaluating new kidney allocation strategies that improve access to well-matched kidney transplants.

“Kidney transplantation should be accessible to all. However, disparities still exist, and many patients’ transplants are compromised by systemic barriers to care, such as inability to afford immunosuppression. I am grateful to AKF for this opportunity and hope our work will increase equitable access to well-matched, successful kidney transplants.” —Dr. Caldwell



Dr. Janewit Wongboonsin, MD, MS is a clinical and research fellow in the Brigham and Women’s Hospital- Massachusetts General Hospital Renal Fellowship Program and is

conducting his post-doctoral research at Boston Children’s Hospital. His research aims to expand understanding of the prevalence and clinical impact of nephrotic syndrome genetic variants and create a large, genetically mapped cohort of patients for current and future clinical studies.

“Genomic information has shown promise in assisting with diagnosis and management of multiple diseases. Nephrology is starting to integrate the use of genetic information to help our patients. My research aims to understand the impact of genetic forms of nephrotic syndrome on adults with this disease and to use genomic information to augment the care we provide.” —Dr. Wongboonsin

Advocacy in Action

Unless we make significant changes, the number of people living with kidney failure could be well over 1 million by 2030. Urgent advocacy is needed to educate lawmakers about the stakes for our nation. 2022 was a busy year for our government affairs team as they helped our leaders understand that kidney failure not only disrupts lives, but also has a high cost to society through medical expenses, decreased wages and hospitalizations.

Advocacy Network

For the first time since 2019, 20 AKF Ambassadors drove and flew into Washington, DC from around the country for a day of education and connection. The daylong event included training on using social media to effectively advocate and on telling their story to legislators. They also received overviews of state and federal legislative efforts to advance policy on behalf of the kidney disease community. AKF's Advocacy Network is a voice for kidney patients on Capitol Hill. Ambassadors play a key role in our legislative agenda and bring the real stories of kidney patients to the attention of lawmakers.



I was diagnosed with end-stage renal failure—I was one of those patients that crashed into it. The most important thing about being an AKF Ambassador is seeing a network of other folks who have been through a variety of different stages of kidney disease and experiences. Some like mine and some different. Having this diverse, educated community that is aware of different issues both legislatively and as a resource is very helpful.

Legislative Priorities

Progress on Living Donor Protection

In 2022, nearly 90% of the people on the national organ transplant waiting list were waiting for a kidney. Laws to protect living donors can help reduce the wait time and save lives. AKF's Advocacy Network of more than 20,000 AKF Ambassadors works closely with state legislators to advance legislation that protects living organ donors and removes barriers to organ donation.

We made significant gains at the state level, with living donor protection laws passed in Delaware, Florida, Georgia, Louisiana, Minnesota, Nebraska, New York, Ohio, and Virginia. One of the most significant advancements was the passage of a groundbreaking law in New York that provides direct reimbursements of up to \$10,000 to living organ donors for expenses associated with organ donation not covered by insurance. Despite this progress, AKF's Living Donor Protection Report Card showed an average U.S. grade of D and we will continue to push for protections in more states in the coming year.

At the federal level in 2022, AKF's advocacy team continued to build support for lifesaving legislation important to the kidney community.

- **Living Donor Protection Act**, designed to protect living organ donors from discrimination by life insurance, disability insurance and long-term care insurance providers and guarantee Family Medical Leave Act medical leave protections to take time off to donate an organ and recover from surgery without fear of losing their job.
- **Medigap Expansion Act**, ensuring that ESRD patients under age 65 have access to Medicare supplemental insurance.
- **Health Equity and Accountability Act** which would expand public health awareness and screening for kidney disease with a strong focus on health equity.
- **CARE for All Kidneys Act**, introduced to address gaps in care.

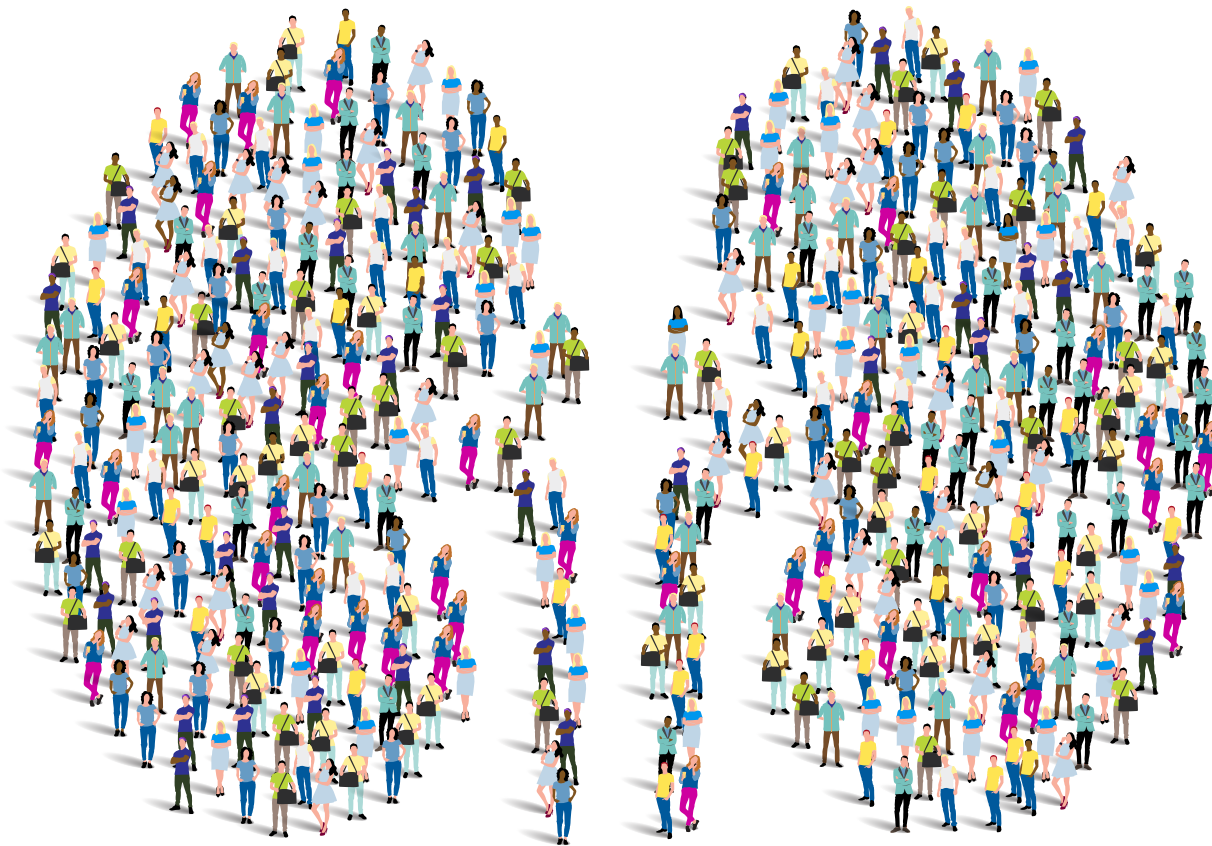

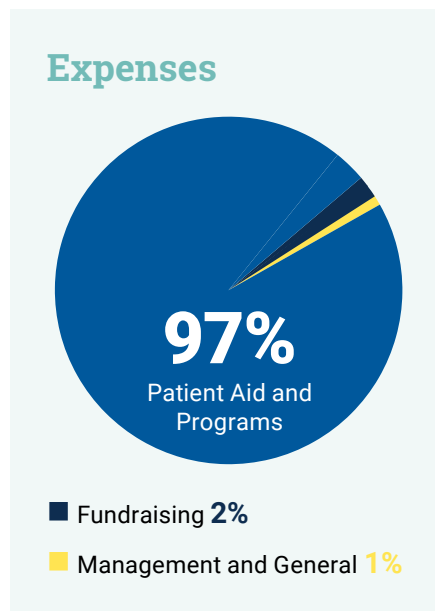

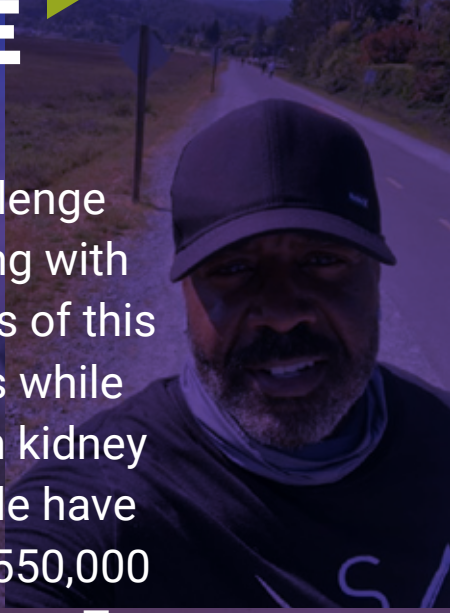
