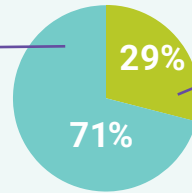

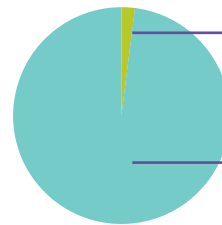


LEADING CAUSES OF CHRONIC KIDNEY DISEASE (CKD)

Kidney transplants in California



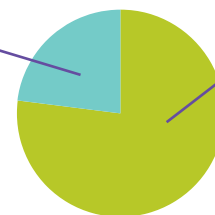

Why people with kidney failure need financial assistance from AKF:
